**THE ANNUAL BUSINESS BURGLAR ALARM SYSTEM PERMIT MAY BE REVOKED UPON FAILURE OF THE PERMIT HOLDER TO COMPLY WITH ANY OF THE FOLLOWING AND OR ANY OTHER PROVISIONS OF THE ALARM ORDINANCE:**

- ALL BURGLAR ALARM SYSTEMS DESIGNED AND INSTALLED TO BE MONITORED OFF PREMISES SHALL BE INSTALLED BY PERSONS AUTHORIZED PURSUANT TO THE PROVISIONS OF THE TEXAS PRIVATE INVESTIGATORS AND PRIVATE SECURITY AGENCIES ACT.
- A VALID PERMIT SHALL BE OBTAINED TO OPERATE, TO INSTALL OR MAKE ADDITIONS TO THE ALARM SYSTEM.
- BURGLAR ALARM OR HOLD-UP ALARM SYSTEMS SHALL BE INSTALLED SEPARATELY FROM FIRE ALARM SYSTEMS.
- ALL BURGLAR ALARM SYSTEMS SHALL BE EQUIPPED WITH SHUT-OFF DEVICES DESIGNED OR ADJUSTED TO SHUT OFF THE BURGLAR ALARM SYSTEM'S AUDIBLE SIGNAL WITHIN FIFTEEN (15) MINUTES AFTER ITS ACTIVATION.
- A CERTIFICATION SHALL BE OBTAINED ALONG WITH THIS APPLICATION INDICATING THAT THE ALARM SYSTEM IS IN COMPLIANCE WITH THE REQUIRED SHUT-OFF DEVICES.
- ALL REQUIRED PERMITS SHALL BE POST AT THE ALARM SITE.

**PERMIT FEES**

THE ANNUAL PERMIT FEE FOR A BUSINESS BURGLAR ALARM SYSTEM---\$40.00  
(ALARMS SYSTEM PERMITS WILL EXPIRE ON DECEMBER 31ST OF THE YEAR THAT IT WAS ISSUED.)

THE PERMIT FEE FOR THE INSTALLATION OR ADDITION TO A BUSINESS BURGLAR ALARM SYSTEM---\$40.00  
(THE PERMIT FEE SHALL BE OBTAINED PRIOR TO THE INSTALLATION OR ADDITION TO THE BURGLAR ALARM SYSTEM.)

**FALSE ALARM FEES**
